Please be aware of the following terms of agreement:

Minimum wholesale orders: Minimum wholesale order is twelve frames.

New Accounts: All Initial orders will be paid by credit card. We accept Visa and Mastercard. Net thirty (30) day terms are available to companies with a satisfactory credit rating; download a credit application for an open account. Please allow two (2) weeks for a response to your request.

Credit Card Orders: Orders being paid by credit card will be charged when the order is shipped. Any declined credit card orders will be cancelled.

Shipping: Standard shipping is via UPS ground. Shipping and handling are FOB Chicago, IL. Shipping is calculated, added to your total, then billed to your credit card.

Product Warranty: Any defective product will be replaced by a new product or part, free of charge, within one month of purchase.

Damaged merchandise: Damaged merchandise or shortages must be reported with seven (7) days of receipt of shipment.

Returns: No returns will be accepted without proper authorization. Return merchandise authorizations (RMAs) are valid up to thirty (30) days.
